

They are bringing their popular Hazardous Materials Instructor Training (HMIT) Program to Baltimore in 2019, and would love to invite local ASSP members and their colleagues to attend as their guests. Anyone is welcome to attend 1, 2, or all 3 classes.

Beginning in February, we will be hosting the first of 3 modules available in the program, a 1-day "Best Practices in Teaching Technical Subjects". Then returning in April with a 2-day "Hazardous Materials Instructor Training (HMIT)-49CFR" class, followed by a 3-day "HazMat Prep & Response class in July.

The classes to be held in Baltimore are as follows:

February 28, 2019 [1-day "Best Practices"]

April 4 – 5, 2019 [2-day "HMIT"]

July 17 – 19, 2019 [3-day "HazMat Prep & Response"]
