For many years in the Baltimore area attempts to form an A.S.S.E. Chapter have been unsuccessful. However, in September of 1961, a group of more than 70 men were assembled in response to a questionnaire and invitation to make one last effort to acquire A.S.S.E. affiliation. With the very fine cooperation of Mr. Art Christian and yourself, this group has been meeting monthly as the Chesapeake Society of Safety Engineers. Minutes of these meetings have been forwarded to the American Society of Safety Engineers each month.

Through cooperative agreement with the Washington Chapter of A.S.S.E. our group expects to draw membership from the entire state of Maryland with the exclusion of Prince George's and Montgomery Counties wherein many of the Washington Chapter members reside.


